LOCATION

Aven Industrial Estate is close to the major eastern motorway networks, ideally located and conveniently fronts on to the A631 Tickhill Road, approximately 1 mile east of Maltby Town Centre.

- The A631 provides direct access to Junction 1 of the M18, which is approximately 3.5 miles to the west, which in turn gives access to both the A1 and M1.
- 6.6 miles from Conisbrough Train Station, where you can access routes for Hull to Sheffield via Doncaster and Sheffield to Scunthorpe via Adwick.
- 11.2 miles away from Doncaster Sheffield Airport, which is accessible via the A631.
- Alternatively, Manchester Airport is 61.5 miles away.




